

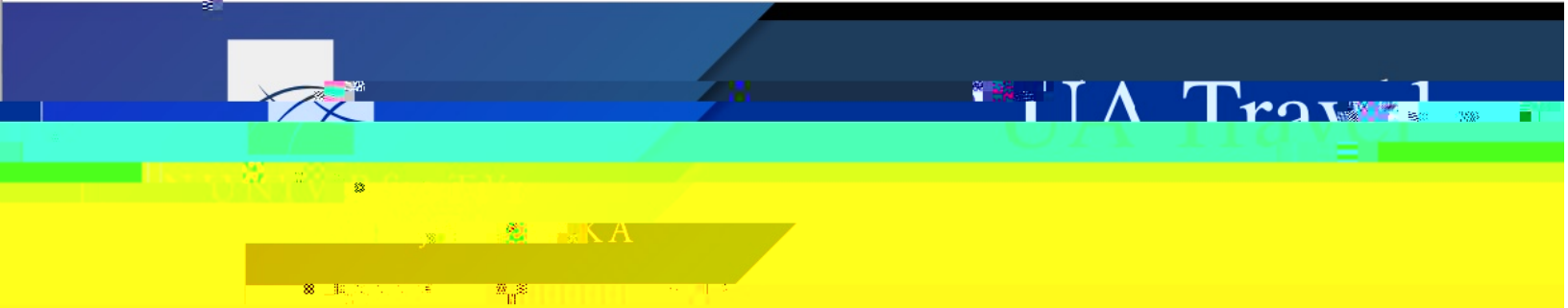
Required Approvals

- b. The Approvals module

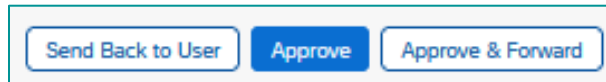

- c. Approve & Forward – Opens window to approve and send Report to an additional approver
